This update is ideal for supervisors and/or anyone with safety and health responsibilities. The latest CAL/OSHA policies, procedures and standards as well as general industry safety and health principles will be reviewed. Special emphasis will be placed on Injury & Illness Prevention Programs. Workers Comp Insurance Companies are now required by law to review your Company's Injury & Illness Prevention Program.

Why worry about CAL/OSHA????

- Increased the penalties for a Serious Violation from \$7,000 to \$25,000. The base is now \$18,000.
- The penalty for failure to abate a violation has been increased from \$7,000 to \$15,000 per day.
- Willful Violations increased to a maximum of \$70,000.
- Criminal liability for OSHA violations has also been expanded.

No financial adjustments are applicable to a serious violation which causes death, serious injury or exposure **OR** if employer does not have an **OPERATIVE** Injury & Illness Prevention Program.
